1- General Information Regarding Your Application Right

In accordance with Article 11 of the [Personal Data Protection Law](#) No.6698 ("Law"), as the data subject you may make the following requests by applying to **Beşik İnşaat Taahhüt Turz. Tic. Ve İth. İhr. San. Ltd. ŞTİ. A.Ş.** ("Company")

Learn whether or not personal data is processed,

Request information as to the processing of personal data,

Learn the purpose of personal data processing and whether this data is used for the purposes intended,

Know the third parties to whom personal data is transferred to in Turkey or abroad

Request rectification of personal data if data is processed incompletely or inaccurately

Request the deletion or destruction of personal data in accordance with Article 7 of the Personal Data Protection Law No. 6698,

Request notification of the transactions carried out in compliance with the 5th and 6th requests (sub paragraphs) stated above as to the third parties to whom personal data has been transferred to,

Object to the occurrence of any result that is detrimental to the data subject by means of analysis of personal data exclusively through automated means,

Request compensation for the damage arising from the unlawful processing of personal data.

Pursuant to Article 13 of the Law No.6698, depending on the nature of your request our Company will finalize your application as soon as possible and within thirty (30) days at the latest.

2- Application Method

In accordance with Article 13 of the Law No. 6698 and Article 5 of the Communiqué on the Principles and Procedures for Application to the Data Controller, you may lodge an application about your requests within the scope of your rights herein via the following methods:

- i. Filling out and signing the application form and submitting a copy of the form signed with your hand written signature to the Company's contact address in person or via a notary,
- ii. Within the scope of the Electronic Signature Law No. 5070, filling out the application form and signing it with your "secure electronic signature", and sending the electronically signed document via e-mail to the KEP registered e-mail address.
- iii. Filling out the application form and sending it via e-mail to the e-mail address
- iv. info@oceanbluehighclass.com by using the mobile signature or the electronic mail address previously notified to the data controller and registered in the data controller's system.

In order for third parties to submit an application request on behalf of the data subject, there must be a special power of attorney issued by the data subject through a notary public on behalf of the applicant.



Beşik Turizm may request information from the relevant person in order to determine whether the applicant is the data subject, and in order to clarify the matters specified in the application, may ask questions to the data subject about his/her application.
