



## BEŞİK TOURISM GUEST CLARIFICATION TEXT REGARDING SECURITY CAMERAS

Dear OCEAN BLUE Guests,

As Ocean Blue , we respect and value the privacy rights of our guests. Therefore, we would like to provide information about the security cameras in accordance with the “**Personal Data Protection Law**” no. 6698 (KVKK) entered into force for the purpose of protecting the fundamental rights and freedoms with respect to the use of personal data.

Video surveillance activities are carried out by OCEAN BLUE in order to ensure the internal and external security of the buildings and facilities, to control entrances, to apply the safety practices for guests and to fulfil the legal obligations stipulated by the laws.

Camera recordings may be obtained 24 hours a day, 7 days a week with cameras placed at certain locations within the establishment.

Images are recorded by a total of 50 security cameras located at the entrance doors within Beşik Tourism , the exterior of the building, general guest and staff areas, restaurants, A la Carte restaurants, bars, lobby, floor corridor , swimming pools, a lot area to ensure the security of the premises, and the recordings are audited by the Security Department.

As stated in article 5 of the “Personal Data Protection Law”, the relevant personal data is processed by automated means based on the legal grounds that “it is mandatory for the data controller to perform their legal obligations” and “it is mandatory for the legitimate interests of the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject”.

The relevant personal data may be transferred to the judicial authorities or the related law enforcement officers upon request to resolve legal disputes or as required by relevant legislation.
